## Our Port - 'First Time 'Round' - Inner Harbour Loop Path competition

#### TERMS AND CONDITIONS

1. The Promoter is the Urban Renewal Authority, trading as Renewal SA, GPO Box 698 Adelaide SA 5001 ("Promoter").

#### **ENTRY**

- 2. By entering into and participating in the promotion, each entrant fully and unconditionally agrees to and accepts these Terms and Conditions and is deemed to have read and understood these Terms and Conditions.
